## Session Descriptions

### Professionalism in the 21<sup>st</sup> Century

Through a collaboration with educators, practitioners and bar leadership, the CLE Board has developed an educational ethics program to explore implicit bias in the legal profession. This interactive, facilitator-led experience presents participants with an opportunity to choose how they would react as bystanders in realistic workplace situations. Group discussion and judgement-free dialogue provide opportunities to reflect on conduct decisions and provoke examination into professional responsibilities. This program was developed as follow up to the CLE Board's highly received diversity, equity and inclusion course, *"Objection."*

### Reimagining Adult Training & Using AI to Reinforce Learning

This session will guide participants through the process of enhancing adult training programs. Through an interactive approach we will undercover adult learner personas and how they influence learning objectives in continuing legal education. An exploration of commonalities between K-12 and adult learners will help us recognize effective engagement techniques and strategies to help ensure that learning takes place. This presentation will include a focus on leveraging AI to create tailored learning experiences that reinforce learning objectives.
